I just want to convey that I want the best for everyone and that I am fair. I will continue to work with other union leaders to expand my knowledge and build on the foundation I've been given. The best way I can be a successful president is to hear feedback from the membership. Right now, the BEA (teacher union) is in the infant stages of negotiating their contract, so there is nothing to report on regarding our negotiations since we haven't begun the process yet. We have a busy year ahead of us! Other recent business to mention regarding the district's insurance plan is that auditors recommended a 0-2.6% increase and SD2 went with a .5% increase to the medical premium. We have a healthy insurance fund but the reasoning behind this given was that they rather raise it a little bit now than have no increase for a while, only to be hit hard with a larger increase later. The Dental Plan did not have an increase this year. For each eligible employee, the District will continue to pay the full single medical/dental premium on the \$1,000 deductible plan.
